## **POLICY FOR SWKKF AFFILIATION**

---

The purpose of this policy is for affiliation into the Shintani Wado Kai Karate Federation (SWKKF).

Throughout this manual the **SHINTANI WADO KAI KARATE FEDERATION** will be referred to as the **SWKKF**.

## **SUPPORTING DOCUMENTATION**

---

The following supporting documents are used as reference in the policy for SWKKF Affiliation:

- POLICY #1 - SWKKF Constitution and Bylaws
- POLICY #2 - SWKKF Standards and Ethics
- POLICY #16 - SWKKF Intellectual Property

## **CRITERIA**

---

An affiliate club or organization:

- 1) Is defined as a non-member of the SWKKF and cannot have been a member of the SWKKF after January 01, 2015, except for those clubs or organizations that were recognized prior to the above date.
- 2) Shall have a senate sponsor or designate, and shall be approved by the senate.
- 3) Must have a minimum of 6 members.
- 4) within Canada shall pay the same fees as a member club or organization within Canada
- 5) Shall be allowed to keep its own club or organization name, as well as their own style, and be allowed to conduct their own gradings.
- 6) Will have all the benefits and rights to services of the SWKKF Organization with the exception of voting privileges.
- 7) Shall abide by the SWKKF constitution, bylaws, standards and all policies.
- 8) When competing in a SWKKF sanctioned tournaments, shall abide by the SWKKF rules and kata will be judged on form and spirit.

## **SWKKF INSURANCE**

---

Only registered affiliate members within Canada qualify for SWKKF insurance.

## **FEES**

---

The fees for an affiliate club or organization outside of Canada shall be determined by the senate.

## **NON-COMPLIANCE**

---

Failure to follow and adhere to any of the SWKKF Policies may result in the revocation of the organization or club's affiliate status.

---
